- Remember, inappropriate* posts or comments may be moved, edited or deleted by A4PEP
 Education Community moderators, at our sole discretion. Inappropriate posts can also be flagged
 by other users at any time and then investigated by A4PEP Education Community moderators.
 Inappropriate posts can include anything that may be viewed as defamatory, libelous,
 antagonistic, off topic, or even be considered an invasion of privacy or violation of the rights of
 another user, person or party.
- Do not use the community to advertise employment positions or solicit business for a product or service that you provide. If your experience with a third-party product or service may benefit the discussion or community, please share your experience with the group in a respectful way.  - **Unwelcome attention: any communication that continues after the recipient has asked you to stop.
 - ***Harassment: conduct which annoys, threatens, intimidates, alarms, or puts a person in fear of their safety.

Discussion Group Etiquette

- State concisely and clearly the topic of your comments in the subject line. This allows members to respond more appropriately to your posting and makes it easier for members to search the archives by subject. If your post does not have a concise or clear subject, you may be advised by an A4PEP Education Community moderator to update the subject before it can be posted. Do not include another member's name in your subject line.
- Send messages such as "thanks for the information" or "me, too" to individuals, not to the entire list. Do this by using the "Reply Privately" link in every message. To access it, click on the downward arrow next to the "REPLY" button and a drop-down menu will appear.
- Refrain from sending administrative messages, such as "remove me from the list," to the group.
 Instead, use the web interface to change your settings or to remove yourself from a list. If you are changing email addresses, you do not need to remove yourself from the list and rejoin under your new email address. Simply change your settings.
